COST OF TOUR: \$2,995 per person for 11 day tour, \$3,990 per person for 16 day tour.

Early reservation is essential as availability is limited. Reservations are confirmed only upon receipt of a SIGNED application and a \$1,000 non-refundable, non-transferable deposit for the 11 day tour or \$1335 for the 16 day tour . We accept Visa / MasterCard / Discover and personal checks made out to Linden Centre, LLC.

Remaining balance is due in two payments: \$1,000 for the 11 day tour by December 1, 2009 and \$995 by January 15, 2010. \$1335 for the 16 day tour by December 1, 2009 and \$1320 by January 15, 2010. These two payments are non refundable after January 15, 2010.

Single room supplement reservation is an additional \$500 after the stated program price.
